SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If unconscious, put the person in the stabilized (recovery) position on his side with his head slightly bent backwards and make sure that airways are free; never induce vomiting. If the person vomits by himself, make sure that the vomit is not inhaled. In life threatening conditions first of all provide resuscitation of the affected person and ensure medical assistance. Respiratory arrest - provide artificial respiration immediately. Cardiac arrest - provide indirect cardiac massage immediately.

Rinse contaminated areas with a flow of water, lukewarm at best, for 10-30 minutes; do not use any brush, soap or neutralizers. Depending on the situation, call the medical rescue service and always ensure medical treatment. Rinse cautiously with water for several minutes. Rinse skin with water or shower.

If in eyes
