Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention. If necessary, call a poison center or physician. 5.2 Special hazards arising from the substance or mixture

For non-emergency personnel

6.2 Environmental precautions

6.3 Methods and material for containment and cleaning up

Small spill

8.2 Exposure controls

Appropriate engineering controls
