### 4.1 Description of first aid measures:

**By inhalation:**

## SECTION 11: TOXICOLOGICAL INFORMATION

### 11.1 Information on hazard classes as defined in Regulation (EC) No 1272/2008:

The experimental information related to the toxicological properties of the product itself is not available
